### Other Important Points

- A. Fee files have already uploaded on the State Bank of India & Punjab National Bank website. Students may start depositing the fee online now.
- B. Further, in case of any problem like mismatch of fee/ category/ status shown in the file available online, the students may deposit the fee directly in the Accounts Office through D/D in favour of **Registrar, IIT Roorkee** or through deposit slips.
- C. In case of any problem like non generation of fee-receipt after depositing online fee/double deduction of fee/mismatch of fee/category status shown in the file available online, the students may either contact in the "Student Affairs Section" (Ph. No. 01332-284222/4285) or an email may be sent at the **email id: anupam@iitr.ac.in**.
- D. A new facility has also been introduced to on-line deposit of various dues/fee of students related to late registration/pre-registration/subject registration/pre-subject registration, dissertation fee, transcript fee, degree fee, duplicate certificate, mark sheet fee etc. it can be done by clicking:

**Fee only from Education Loan from Banks**


Students availing loan from the banks may deposit the Fee as per following:

1. Loan provider bank may directly transfer the funds to IIT Roorkee **through RTGS/ NEFT** as per following details:

Thereafter, student has to submit the RTGS/NEFT Reference Number in the SA & Cash Section, Finance & Accounts office, IIT Roorkee for verification of the fee deposited.

2. **Through Demand Draft:** Fee from loan may also be deposited directly in the Accounts Office. Draft shall be prepared in favour of **Registrar, I.I.T. Roorkee** payable at Roorkee only.
