4. Quotation to be submitted by the vendor/firm on its official letter head.
5. The rates quoted should include GST tax or any other taxes and duties inclusive.
6. The rates should remain valid for a period of 90 days from the date of issue of your Quotation.
7. There should not be any over-writing or cutting on rates quoted. However, all cutting/corrections must be duly authenticated.
8. The rates shall not be subject to escalation of any nature.
9. The rates quoted should be applicable to educational institutions and any cost advantage received in lieu thereof should be passed on the Institution.
10. Purchase Committee of Anushruti Academy for the Deaf will have the right to reject any Quotation without giving any explanations to the Firm.
11. In the event of any difference or dispute arising out of this purchase, all efforts shall be made by same amicably.
12. Warranty period for each item must be clearly mentioned.
